### Partnering Programs

In 2008, CHPE, partnering with a number of community organizations, began hosting events, not merely open to community members, but seeking out a shared community engagement. 2008, Creighton Alum, September Williams, MD, discussed the history of African American surgeons through her perspective as a physician and filmmaker who examines ethical issues in health care. 2009, Author Barbara Delinsky spoke to breast cancer survivors at a luncheon including women from My Sister's Keeper Support Group. May, 2010 School of Medicine Distinguished Lecture Series speaker Dorothy Roberts, JD, met with community members to discuss her book, 'Killing the Black Body', outlining past medical abuses and current medical neglect of African American populations. September, 2010 Partnering with Omaha Table Talk and other organizations, CHPE hosted a book discussion on 'The Immortal Life of Henrietta Lacks' by Rebecca Skloot. >November, 2010 School of Medicine Distinguished Lecture Series speaker Dayle B. DeLancey, PhD, met with community members, Creighton and Methodist College health sciences students, and Creighton faculty and staff to discuss 'How History Shapes African American Health Today'.
